Papers of Alfred King, youngest son of Thomas and Sarah Wilson King and other family members. Alfred King was prothonotary and clerk of courts of Erie County. For two years he was treasurer of the county and served two terms as mayor of Erie. He engaged extensively in manufacturing and also dealt largely in grain, particularly in Barley. He was also interested in real estate, both in Erie and the midwest. His wife was Mary Kennedy. Their children are also represented in the papers: Kennedy; Josiah Holdship, 1st lieutenant in the 8th U. S. Cavalry; Alfred H., commission merchant of Erie; Annie; Katherine; Sarah. Other family members represented are brothers and sisters of Alfred: Wilson, civil engineer and contractor; Josiah, prominent Pittsburgh manufacturer and publisher of the Gazette; Nancy and husband Alexander Blaikie; Caroline Clarke and son James P.; and Paternal Grandparents of Alfred, Robert and Elizabeth King.
