#### THOMAS KRAMER COLLECTION, 1780-1889

### (JUSTICE OF PEACE, PALMYRA, LEBANON CO., 1844-1889)

The personal and public papers of Thomas Kramer, justice of the peace at Palmyra, Pennsylvania from approximately 1844 to 1880. Contains agreements, summons, warrants, leases and other diverse documents filed with the justice of peace in Lebanon County (particularly the Palmyra, Campbelltown, & Londonderry areas) from 1813 to 1880. Also included in the collection is a handwritten manuscript of John F. Wolfinger's "History of Pennsylvania," materials pertaining to the Kramer and Segner families, and misc. papers, land surveys, receipts, and correspondence that date from as early as 1780 onward. Among some of the more noteworthy justices of the peace whose papers appear in the record are Abraham Philips (ca. 1810-1838) and William Geddes (ca. 1839-1844). The overall date of the collection is 1780 to 1889.
