

Amongst the records of the Court of Common Pleas for Bedford County it is Contained, as follows -

Loughry Jeremiah } In the matter of the Application of Solomon Reighard and John G. Hartley  
 Appl. of Hartly & Reighard } for a rule on the Surveyor General of Pennsylvania, to show cause why  
 the lien for the purchase money entered in the Prothonotary's Office against  
 a tract of land (now situate in Snake Spring Township surveyed on a warrant to Jeremiah Loughry,  
 Should not be stricken off the land lien docket so far as said tract interferes with another tract of land  
 surveyed on a ~~trust~~ warrant to Richard Hockley, called "Avon."

Rule issued & Served

June 10, 1870, Answer of Surveyor <sup>General</sup> filed - And it is ordered and directed that testimony be taken at  
 the Court House in the Borough of Bedford on the 2d. day of July next and notice to be given to Surveyor General  
 A. King President Judge.

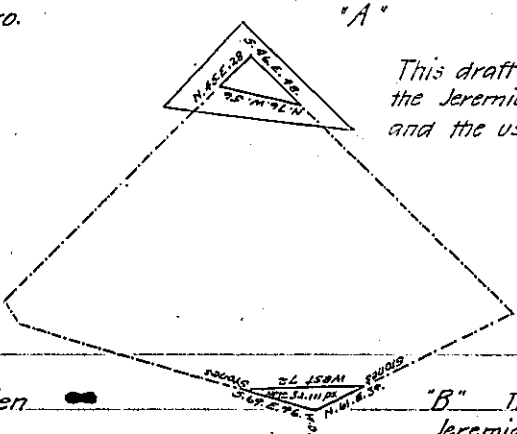
Testimony taken, and drafts, filed August 1st. 1871. Amended petition and order of Judge Hall filed.

And now to wit, Sept 4. 1871, the petition having been amended so as to properly indicate the lien, and the  
 draft and calculations filed in due form, the Prothonotary is hereby directed to strike from the record  
 the lien in favor of the Commonwealth for purchase money &c. against the tract in the name of Jeremiah Loughry  
 so far as the same is covered by the patent issued on the tract warranted in the name of Richard Hockley  
 as indicated in the draft and calculations, to wit, for the whole of said trust except the piece marked "A"  
 containing 3acres, 153 perches and allowance now owned by Solomon Reighard, and the piece marked "B"  
 containing 3acres 77perches and allowance now owned by John G. Hartley.

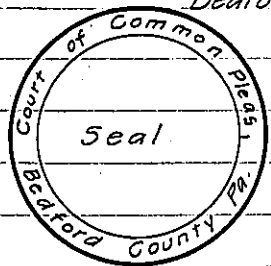
