No. 1 represented by dotted lines is part of a draft of a Tract of Land surveyed for John Creidlen the 26 day of December 1791 on Order No. 1712 dated the 28th day of October 1766. This tract interferes seventy nine acres and eighty seven perches with the Lemuel Barrett survey. John Creidlen conveyed to Charles Coxe - Lemuel Barrett conveyed to Capt. Thomas Bassett from whom Charles Coxe also purchased and then conveyed to John Lazure and William Perdew. William Perdew conveyed ^{part} to Eliza Perdew Esqr. the present owner. William Perdew owns part. No. 2 represented by dotted lines is a draft of a tract of land surveyed for William Cristy the 30th day of October 1791 on Order No. 1752 dated the 30th day of October 1766. This tract interferes sixty eight acres and sixty two perches with the Lemuel Barrett survey. William Cristy conveyed to Charles Coxe who also purchased from Capt. Thomas Bassett to whom Lemuel Barrett had conveyed. Charles Coxe conveyed to Amos Dickens who devised the same to Jesse and Stephen Dickens the present owners. No. 3 represented by dotted lines is part of a draft of a tract of land surveyed for Joseph Stampfer the 25th day of December 1791 on Order No. 1753 dated the 30th day of October 1766. This tract interferes one hundred and eighteen acres and one hundred and fifty nine perches with the Lemuel Barrett survey. Joseph Stampfer conveyed to Charles Coxe who also purchased from Capt. Thomas Bassett to whom Lemuel Barrett had conveyed. Charles Coxe conveyed to William Lazure and Amos Dickens. William Lazure conveyed to Thomas Lazure the present owner of part thereof. Amos Dickens devised his part to Stephen Dickens the present owner of part thereof. No. 4 represented by dotted line is claimed by virtue of a settlement made thirty years ago or in the year 1798 by William Mason who conveyed to Michael Murphey who conveyed to Isaac Denny who conveyed to Jonathan and Stephen Dickens the present owners.
