Located in pursuance of a Contract with the Board of Property for carrying into effect the several Acts of Assembly relating to unpatented lands under Proprietary Rights &c. And by virtue of an Order of Survy dated 15 October 1767, No. 4489, granted John Williamson for 100 acres bounded partly by land late of Richard Peters now Alexander McNight, William Young, Barren Hill & said Williamsons other land extending towards Conodoguinet Creek in Hopewell, ascertained on

 To Jacob Spangler Esqr., Surveyor General Report The above survey is covered by the following Office Rights to wit:
 The part marked A & B is covered by a survey of 64 acres 92 perches, survey'd 8 May, 1787 for John Herran, on a warrant to Robert McNitt dated 30th March, 1763. The figure marked C containing 31 a. 66 ps. is included within the lines of a tract of 115 a. 53 ps. & all s^e survey'd under contract on a Warrant to Robert Bech dated 5 June 1749. That part of the survey marked B enclosed by red dotted lines; was survey'd 14 April, 1768 on an Order to John & Heigh Williamson dated 11 August, 1767, No. 4274, as per List No. 1 of Unpatented Lands. Note The part C has also been survey'd & included within the lines of 109 a. 64 ps. on a warrant to William Young dated the 30 March 1793 & confirmed by Patent & held under said title. Owned & occupied by David Wonderlich & Jacob Shroll. The part A & B held under to the title to McNitt owned by the heirs of John Herran; occupied by John Davison and George Wilson Wm S. Davis
 Note Order of Survy dated 7 October 1767, No. 4472 granted to John Foley for 50 acres joining John Williams, William McNutt and Robert McNutt in Lurgan, seems to have been intended for that part of the survey marked B.
