Whereas Dirick Sipman of Grevelt in Germany, Original Purchaser of five thousand acres of land in this Province is said to have taken up (by his agent) fifty acres within the Liberties of ye City Philad^{ia} in right of his s^d Purchase, and in right of Govert Rammes Purchaser of one thousand acres ten acres of land within ye s^d Liberties, and Jacob Isaacs van Beber purchaser of one thousand acres, ten acres also within the s^d Liberties, all in pursuance of a Grant from the Prop^{ty} under his hand made at Grevelt in ye year 1686. in w^{ch} ye Prop^{ty} further granted to ye s^d Dirick Sipman in right of his said purchase one acre of land in ye City Philadelphia in some convenient place and to Jacob Isaac one third part of an acre in ye s^d City, and further granted to the s^d Dirick Sipman that for the Thousand acres which he bought of Govert Rammes he should enjoy the same privilege as above mentioned And whereas the s^d Dirick Sipman as hath been made appear to us, hath sold and conveyd to Matthias van Beber of Philad^{ia} afores^d all his Right Title & Interest whatsoever in and to all his lands whatsoever within the s^d Province as well to ye Purchase of one thousand acres made by Govert Rammes with its Appurt^{ances} as to his own purchase of five thousand acres wth its Appurt^{ances} afores^d & the s^d Jacob Isaacs van Beber hath also given and granted all his right to what land he hath not otherwise disposed of of his s^d Purchase ~~these~~ these to his son ye s^d Matthias van Beber. These therefore are to authorize & require thee to resurvey to ye s^d Matthias all the several parcels afores^d within the s^d Liberties if to be found & not yet disposed of Also to survey & lay out to him ye s^d Matthias one acre in some convenient place of ye s^d City in right of ye s^d Dirick Sipman & one third part of an acre in right of Jacob Isaacs, also one third part of an acre in right of Govert Rammes where not already surveyd taken up for Appropriated & make returns into ye Gen^l Surveyors office at Philad^{ia} where this warrant is to remain & a copy y^{of} to be deliv^{ed} to thee certified by ye Secretary.
