Whereas the Commissioners of Property. By their warrant dat^d the 30th day of July 1712 Granted to Isaac Norris Esq^r Ten acres of Libertie land in the Right of William Lovel, and by their ^{other} Warr^t dat^d the 25th day of y^e first month 1715. Required me to survey to John Falconar & Andrew Hamilton sixty acres of ~~land~~ land in y^e Liberties of Philadelphia which right of sixty acres was conveyed by Andrew Hamilton & Gilbert Falconar Brother & Attorney to y^e s^d J^r Falconar. ^{among other lands} ~~by~~ To y^e s^d Isaac Norris by deeds dat^d y^e 22nd & 23rd days of Aprill 1715. And whereas the s^d Commiss^{rs} ^{further} By their warrant dat^d the 16th day of Jan^y in y^e year 1726 Granted to y^e s^d Isaac Norris. Thirty six acres of Libertie land in right of Charles Marshall Jun^r Smith & Comp^{rs}. And the s^d Commiss^{rs} having also Granted by their warr^t dat^d y^e 10th day of Jan^y in y^e year 1721. Granted to J^ro. Davies twenty acres of land in y^e right of William Kents Purchase of 1250 acres. The right of w^{ch} twenty acres is now invested in y^e s^d Isaac Norris ~~Esq^r~~. Now this may certify That in pursuance of ^{the} ~~the~~ warrant and rights above mentioned. I have survey'd and laid out severall ~~peels~~ ^{lots} of land w^{ch} in the Northern Liberties as follows That is to say I did on the first day of 9th 1715. Lay out unto Nich^l Wain assignee of y^e s^d Isaac Norris twenty acres of land. And I did on y^e 23rd day of Aprill 1723. Survey a piece of land Beginning at a corne^r post at a corne^r of Thomas Callowhills land & running by oth^r land of y^e s^d Isaac Norris south south east One hundred & five perches to a post. Then by Job Goodsons land west south west sixty three perches to a post then N.N.W by the s^d Goodsons land nortely two perches then on y^e same course thirteen perches by Tho. Callowhills land to a post then by another line of y^e s^d Callowhills land E. N. E. sixty three perches to the place of Beginning containing forty acres And I did on the 20th day of 8th 1727 Survey a ~~the~~ piece of land Beginning &c. [here y^e 34 acres bounds] And on the same 20th day of 8th I did further survey & lay out another piece of land. Beg &c. [here y^e 26 acres] And for the full completing of all y^e above mentioned warrants & rights. I did on the day [here y^e 6 acres by y^e rock on Sculkill—]
