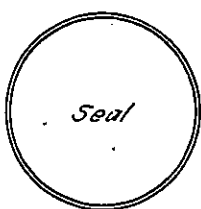


In pursuance of an agreement made between John Penn, Thomas Penn, Richard Penn and Thomas Freame for dividing into four equal parts the Tract of Land called Perkiomky in the County of Bucks in the Province of Pennsylvania, John & Richard Penns Concurrence appearing by Letter from John Penn dated the 28th day of Janry 1733 & Thomas Penn & Thomas Freame being present this Ninth Day of Oct 1733 the Allotments were made in the Manner proposed by the sd Letter & Agreement of Parties present &obliterated are now marked in y^e above Plot, Wee whose Names are on the Back hereof being present as Witnesses -

By the Proprietarys

Whereas our late Father did, by Letters Patent bearing Date the Twenty fifth Day of October One thousand seven hundred & one, give grant & confirm unto Samuel Carpenter, Edward Pennington and Isaac Norris, all of the City of Philadelphia, and to the Survivors or Survivor of them a certain Tract of Land in the County of Bucks in this Province beginning at a white Oak standing on the North Side of the Main Branch of Neshamint Creek in the Line of the Land that was about that time belonging to Captain Hudson, from thence running North West by the said Line, and by the Land reputed to be Coll^o Mildmayes One thousand six hundred Sixty eight Perches to a black Oak marked for a Corner; then North East by vacant Land Nine hundred & Sixty Perches to a Corner marked white Oak; thence South East by the Land laid out to Henry Goldney & Company One thousand Six hundred sixty eight Perches to a Post standing on the South Side of a small Run of Water; thence South West by the Land of the said Henry Goldney & Company Nine hundred & Sixty Perches to the Place of beginning, containing Ten thousand Acres of Land, to be holden by the said Samuel Carpenter, Edward Pennington & Isaac Norris in Trust for his Son John, then born, & for other Children that should be begotten by our said Father on the Body of his then Wife Hannah; And whereas it has been agreed between John & Richard Penn, Margaret Freame & Thomas Penn that the said Tract of Land (Part of which by the Misconduct of the Surveyor, has been laid out to other Persons) should be equally divided amongst them; These are to authorize & require thee to resurvey & divide, or cause to be resurveyed & divided the said Quantity of Land according to the Draught hereunto annexed; & make exact & particular Returns thereof into the Secretary's Office in the Names of my said Brothers, Sister & my Self- Given under my Hand, & the lesser Seal of our Province, at Philadelphia this tenth Day of August Anno Domini 1733.
