

Whereas six Patents for donation land have been granted to me by the Commonwealth of Pennsylvania, dated the 4<sup>th</sup> of May 1795, or sundry Assignments, Powers and Orders, some of which may hereafter be disputed: Therefore, for the more perfect security of the Commonwealth, I hold myself, my heirs, executors and administrators, accountable to the Parties so claiming, and to indemnify the Commonwealth in the premises; and also to execute such farther and other obligation of this kind, and for this purpose, as shall hereafter be reasonably required Given under my Hand and Seal this fourth day of May Anno Domini 1795.
