



A Draught of Two Tracts of Land Situate in Lower Milford Township in the County of Bucks, in the State of Pennsylvania. The first, including the Messuage is the greatest Part of a Tract of 21 acres and 148 per & allowance - which formerly was Surveyd to Philip Kuhnius by Warrant of the 22d. April 1740, Who on the 12<sup>th</sup> Decemb<sup>r</sup> 1748, Sold his Right to the Same to Rudolph Frick who on the 22d. January 1768, Sold the same to Benjamin Summer, and he again on the 19<sup>th</sup> January 1775, to Philip Sholl who died May 24<sup>th</sup> 1783, whose Executors George Wickard and Peter Sholl Sold all his Estate as directed by the Will dated March 18<sup>th</sup> 1783 and consequently the above Two Tracts thereof to William Jameson. — — — The First Tract Beginning at a Stone in the Line of Frederick Wambolds Land Thence by the Same, South 22 degs West 67 perches to a Stone and South 68 degs West 22 perches to a Stone and South 72 degs West 30 perches to a Stone and South 80 deg West 20 perches to a Stone Thence continued by the Same and by a road leading to Cosbehoppen North 83 degs West 76 perches to a Stone, a Corner of the hereunto described Second Tract thence by the Same North 5 degs East 74 perches to a Stone in the Line of Philip Heagers Land, Thence by the Same East 162 perches to the Place of Beginning Containing 71 acres and 112 perches of Land Strict — or Sixty Seven acres and 103 Perches of — together with the usual allowance for Roads. — — — The Second is Part of a Tract of above 50 acres, formerly Surveyd to Jacob Houser by Warrant dated the 5<sup>th</sup> November Anno 1742 and afterwards Sold to Sholl Beginning at a Stone, a Corner of Frederick Wambolds Land, Thence by the same North 83 degs West 27 3/4 perches to a Stone and North West 61 perches to a Stone a Corner of Christopher Sacks Land, Thence by the Same North 1 deg West 27 1/2 perches to a Stone in the Line of David Mucklys Land Thence by the Same and by Land of Philip Heager East 77 3/4 perches to a Stone, a Corner of the above described first Tract Thence by the Same South 5 degs West 74 perches to the Place of Beginning Containing 26 acres and 144 perches of Land Strict — or Twenty Five acres and 60 perches of Land, and the usual allowance for Roads, Surveyd for the said William Jameson on the 5<sup>th</sup> August Anno 1783.
