and Summs of money Debts goods wares Dues accounts
and other Demands whatsoever which case or shall
be Due owing Payable and belonging to me or
Detained feloniously any manner of ways or means
whatsoever by the Honorable the assembly of this State
the united States the Quarter master Generals Depart-
ment and giving and granting unto my said Attorney
by these presents my full and whole Power Strength and
Authority in and about the Premises to have use and
take all Lawfull ways and means in my Name for the
Recovery thereof and upon the Right of any such Lands Debts
Dues or Summs of moneys aforesaid acquittance or other sufficient
Discharges for me and in my Name to make Seal Deliver
and Generally all and Every other act or acts thing
and things Devise and Devises in the Law whatsoever
needfull and Necessary to be Done in and about the premises
