which I may have, or which I may hereafter have, to all and singular the Lands,
Pay, Arrearages of Pay, Clothing, Rations, Rewards, Bounties, Gratuities, Prize-Monies, and other De-
mands, due and owing to me, from the United States, or from any particular State. And I do hereby for my
self, my Heirs, Executors and Administrators, covenant and agree to and with the said Daniel
Stever his Heirs, Executors, Administrators and Assigns, that I, my Heirs,
Executors and Administrators, shall and will, at any Time or Times hereafter, at the Request, Cost and Charges
of him, his Heirs, Executors, Administrators and Assigns, make, seal, execute and deliver, or cause or procure
to be made, sealed, executed and delivered, all and every such reasonable Act and Acts, Thing and Things,
Conveyance and Conveyances, Assurance and Assurances in the Law, for the perfect granting, conveying, re-
leasing, transferring and assigning, all the Right, Title, Interest, Property, Claim and Demand, which I now
have, or which I, my Heirs, Executors or Administrators, may at any Time hereafter have, of, in and to, all
and singular, the Lands and other the Premises, hereby granted and assigned unto him, his Heirs, Executors,
Administrators and Assigns for ever, as by his or their Counsel learned in the Law shall be reasonably advised,
devised or required. And I do hereby make, constitute and appoint the said Daniel Stever
my true and lawful Attorney, irrevocably, to ask, demand, recover and receive, of and from the United States,

any Manner of Ways or Means whatsoever, and upon Receipt thereof, to execute and deliver sufficient and requi-
site Receipts, Releases and Acquittances, and to execute and deliver sufficient and requi-
site Receipts, Releases and Acquittances, to the Purchaser, or Purchasers, of the same Lands, or other Stock, now
or hereafter standing in my Name, or their Heirs and Assigns for ever. And also to sell, assign and transfer all Certificates, and Registered
or other Stock, now or hereafter standing in my Name, or their Heirs and Assigns for ever. And also to sell, assign and transfer all Certificates, and Registered
in the Books of the Treasury of the United States, or of any particular State, for, or in Consequence of my
Services as aforesaid, with Power an Attorney or Attornies under him, for the Purposes aforesaid, to make,
and substitute, and to do all lawful Acts requisite for effecting the Premises, as fully and effectually to all Intents
and Purposes, as I might or could do by being Personally present, and to have done the same, hereby allowing,
ratifying and confirming all and whatsoever, my said Attorney, or his Substitute, or Substitutes shall, or may do,
