 Wherof Acquitted and forever discharged Made granted bargained sold aliened conveyed and confirmed and in these Presents do grant bargain
 Conferme unto the Said William Lewis his heirs and assigns a certain Tract or Parcel of Land lying in the County of West Moreland in the Tenth District of
 PENNSYLVANIA at a Birch Tree the numbered Corner the Running East by Lot No 2144 two hundred and Sixty one Perches to an Ash tree thence
 and thence thirty Perches to a Birch tree thence West by Lot No 2142 two hundred and Sixty one Perches to a Birch tree thence North by Lot
 and thirty Perches to the Place of Beginning containing two Hundred Acres and Allowance Six Percent for roads & Highways MCMXXIII It being
 Land granted by Patent under the Name of the Honorable Charles Brooke Esq. Vice President and then of the State of Pennsylvania bearing Date the
 17th of June 1766 unto Michael Kelly Private as in and by said Patent well appears and which the Said Michael Kelly by Instrument will appear together
