June 13<sup>th</sup> Peter Bates Negro aged upwards of sixty or is supposed, (he not knowing his age) late from Old Chester Delaware County, intends to reside with his wife Sally only, in this City, he being by occupation a labourer, who is worth about thirty pounds some when spring garden, he is about taking a house for himself &c

June 14<sup>th</sup> Elizabeth Sumner Negro aged thirty eight years or thereabouts, late from Charles Town & now in Annapolis, single woman, no family, resides with Charles Green of below, in a house of Bobbin Skiffen just at the head of North Street

June 16 Charles Enser Negro, aged about twenty eight years, late from Baltimore County State of Maryland declaring his self a freeman, by occupation a cooper, resides with his wife Mary Enser only, in a house belonging to the the mess of Gilmer & in water street

June 20 Thomas Peterson Negro aged about 29 years late from Charles County but has removed his town with William Bawlt of that County, or long in London, resides with Joseph Phelps in Adams town in this house late of Thomas Sumner, has no family but has self by occupation a labourer resides in Adams town

July 13 Perry Blackston Negro aged about 25 years, late from Harrisburg, who has formerly served his term in the State of Delaware, and is now settled at Quaker town under by hand sold.

July 17 Charles Green Mulatto aged about thirty three years, about five feet 11 inches high, late from Little Backs Township residing with Sam Brown in north Pence Street as a singler, entered therefore for himself only by occupation a labourer

July 17 Solomon Johnson Negro aged about 29 years by occupation labourer about five feet 11 inches high, dark complexion about five feet 7 or 8 inches tall, single man, residing as a cooper with Sam Brown in north Pence Street in the City of Lancaster, he is lately from Colerain Township in the town end of Lancaster County

August Henry Clark aged about 28 years a single man (his wife aged about 25 years and she is aged about five years, she had Henry being a labourer by trade, he resides in the same house with Joseph Green of below in the City of Lancaster in a house called town piece

August 23 Ann Robinson a Mulatto Mulatto aged about 16 years, single woman, lately from York Pennsylvania, declares herself a freeman and intends to reside in this City, resides in Pence Street with Sam Brown of Colerain - Both served her term with Peter Smith of York of freedom, for the term of seven years she having a short built girl

Sept 20 Maria Martyn Mulatto, aged about 14 years, single woman, she was formerly the wife of Charles Green who was a cooper in the City of Lancaster, she is now in Pence Street in this house late of Thomas Sumner, she having a short built woman of a fair complexion by occupation a house maid
