Official papers of William A. Stone (b. 1846, d. 1920).
Governor, 1899-1903. He served in the Civil War in Co. A,
187th P.V. and was in the State National Guard. He practiced
law since 1870 at Wellsboro and Pittsburgh. He was District
Attorney of Tioga County, 1864-67; U. S. Attorney for the
Western District of Penna., 1880-86; and in the U.S. House
of Representatives, 1891-99. He was also prothonotary of
Supreme and Superior Courts of Pennsylvania
