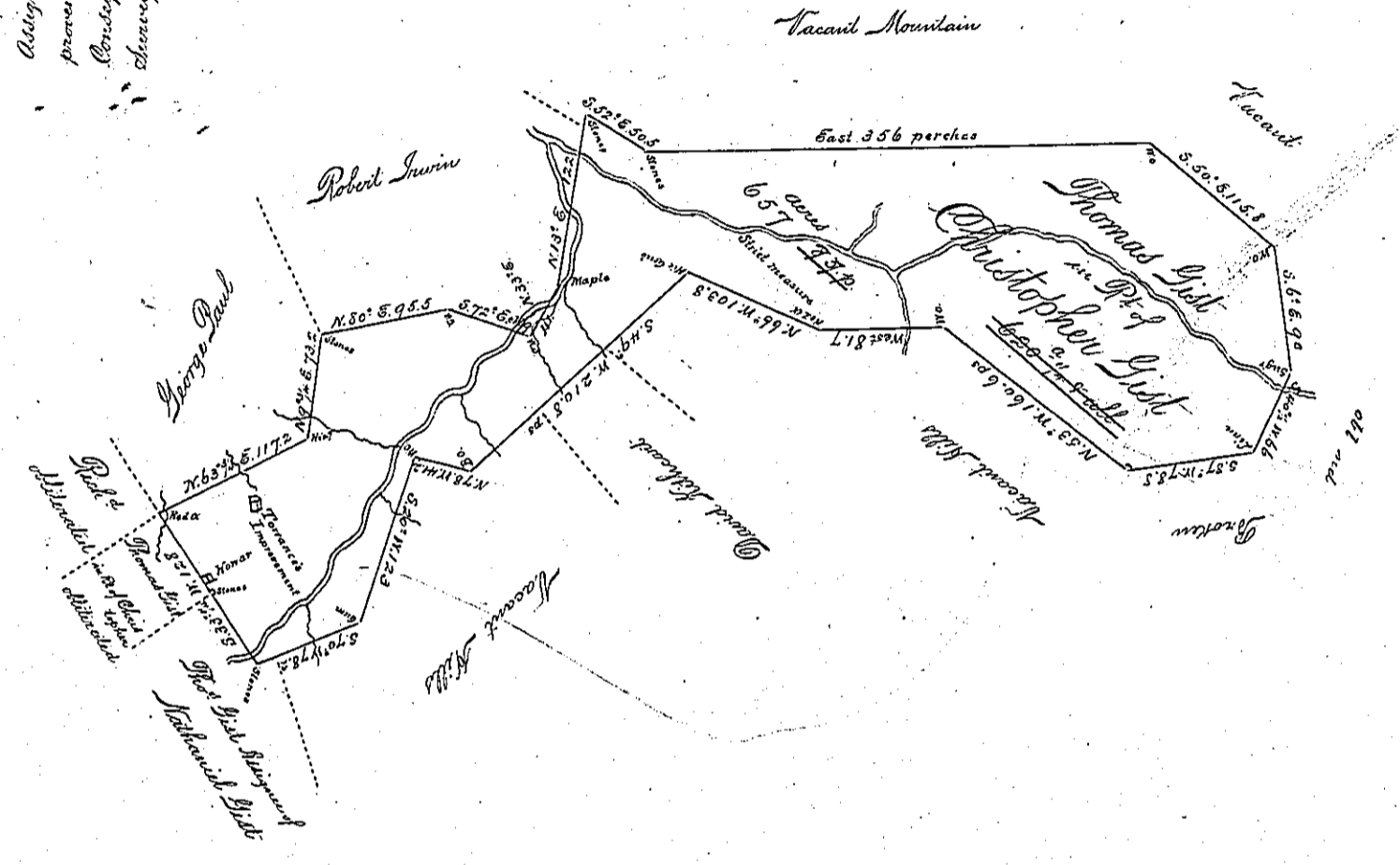

Survey'd the 26th Day of October 1785 In Consequence of a Warrant of Preemption

for 1000^{ac} of which the following is a true Copy LAND OFFICE VIRGINIA Land Office Treasury Warrant N^o 108. — To the principal Surveyor of any County within the Commonwealth of Virginia. — This shall be your Warrant to survey and lay off in one or more Surveys, for Thomas List in Right of his father Christ List his Heirs or Assigns, the Quantity of one thousand Acres of Land, due unto the ^{said} List on Preemption as p^o Certificate from the Commissioners for the District Monongalia, Yohogania & Ohio & in Consideration of the sum of four hundred pounds current Money paid into the publick Treasury; the Payment whereof to the Treasurer hath been duly certified by the Auditors of publick Accounts, and their Certificate received into the Land Office, Given under my Hand, and the Seal of the said Office, on this eighth Day of March in the Year One Thousand Seven Hundred and eighty. [Certified on the Back of the above] S. Carr D. P. L. S.

This Warrant was Produced to me the 8th day of July 1780 when Capt^l Tho^s List made Entry on my Books, for four hundred Acres of Land Part of the one thousand within Merit^d On the Land at present held by Sam^l Lyon Sr & Jun^r Lyon jr bounded by the Line of the s^d List, the Sawmill hill, Isaac Pearce, Jas^l Finley & John Cornhill, a^d Vacant Land, by the s^d Lyons Failing to Enter the same with the Commis^{rs} and Comply with the rules & regulations of the Office & Law in that Case made & Provided. W. Crawford S. Y. C.
