

The courses & Distances of all the Land formerly of Griffith Jones in the Northern Liberties Begin<sup>d</sup>. at a Post near the Mouth of the first Southern branch of Wingocacan Creek then <sup>ought to be S.S.E.</sup> E.N.E. 78 <sup>per</sup> to a post, thence by Land late of Jacob Evans <sup>(E.N.E.)</sup> N.N.W. 56 to a post, then <sup>(S.S.E.)</sup> E.N.E. by <sup>W.S.W.</sup> sd Evans Land 32 <sup>per</sup> to a post then <sup>(W.S.W.)</sup> S.S.E. by <sup>(N.N.W.)</sup> Ld of N. Waln 162 to a post thence <sup>(W.S.W.)</sup> W.S.W. by <sup>(N.N.W.)</sup> same Land 74 <sup>per</sup> then <sup>(W.S.W.)</sup> S.S.E. by <sup>(N.N.W.)</sup> same Land 39, thence <sup>(W.S.W.)</sup> S. 87 W. 137 then <sup>(W.S.W.)</sup> W.S.W. 42 <sup>per</sup> then <sup>(N.N.W.)</sup> S.E. 78 to a post then <sup>(N.N.W.)</sup> W.S.W. by Land of Robt. Greenaway & John Southworth 113 <sup>per</sup> to a post then <sup>(E.N.E.)</sup> N.N.W. by Lands of Tho: Bowman & Tho.  Another of sd Holme by D<sup>d</sup> dated ye 27 of June 1692. another part granted by Pat<sup>t</sup> from the Comm<sup>s</sup> dated ye 24<sup>th</sup> of 8ber. 1701, another part purchased of Tho. Rowland by D<sup>d</sup> dated the 9<sup>th</sup> of Feb. 1686, another part bought of Joseph Crowdon by D<sup>d</sup> dated the 12<sup>th</sup> of Decemb<sup>r</sup>, 1687, and another part from William Salaway by D<sup>d</sup> dated the 10<sup>th</sup> of Augt 1693.

Of this Tract Jo. Jones sells to Richd. Waln a part bound<sup>d</sup> as follows -
