And I do hereby for myself, my Heirs, Executors and Administrators covenant and agree to and with the said *James Bell*

his Heirs, Executors, Administrators and Assigns, that I, my Heirs, Executors and Administrators, shall and will, at any Time or Times hereafter, at the Request, Cost and Charges of him, his Heirs, Executors, Administrators and Assigns, make, seal, execute and deliver, or cause or procure to be made, sealed, executed and delivered, all and every such reasonable Act and Acts, Thing and Things, Conveyance and Conveyances, Assurance and Assurances in the Law, for the perfect granting, conveying, releasing, transferring and assigning, all the Right, Title, Interest, Property, Claim and Demand, which I now have, or which I, my Heirs, Executors or Administrators, may at any time hereafter have, of, in and to, all and singular, the Lands and other the Premises, hereby granted and assigned unto him, his Heirs, Executors, Administrators and Assigns for ever, as by his or their Council learned in the Law shall be reasonably advised, devised or required.
