

Know all men by these presents that I Samuel Harris late a Soldier in the third Pennsylvania Regiment in the Service of the United States of America for value and the full consideration money to me in hand paid at and before the Execution hereof by Josiah Witter of Philadelphia Gentleman the Receipt whereof is hereby Acknowledged have and hereby do grant, Bargain, Sell, Transfer, convey and Confirm unto him the Said Josiah Witter his heirs Executors administrators and Assigns forever all the Right title and interest whatsoever in Law and Equity, which I now have or which my heirs Executors or Administrators may hereafter have, to the Lands pay Depreciation (Cloathing) Bounties towards Bounties Gratuity, and every other Mercenary claim and Demand whatever due and owing me from and by the United States or any particular State, and I do hereby for myself my heirs Executors and Administrators covenant & agree to and with the Said Josiah Witter his heirs Executors and Administrators will at any time hereafter at the reasonable cost and Charges of the said Josiah Witter his heirs Executors Administrators or Assigns make or cause to be made any future conveyances and Assurances in the Law necessary to be done for the further transferring & confirming all and singular the premises & Claims hereby granted and Assigned or intended to be, and do make constitute and appoint the said Josiah Witter to be my true and Lawful Attorney irrevocable to Demand Suitor & receive & recover from the United States or any particular State or any person or persons acting by or under their or either of their Authority all and singular the premises rights Claims and Emoluments herein above recited and sold and now withheld and Detained from me the said Samuel Harris with power also Attorney or Attornies for that purpose to make and Substitute, and to do all Lawful acts requisite for effecting the premises hereby thatifying and confirming all that any said Attorney or Attornies for that purpose substituted shall do therein by virtue hereof for Witness whereof I have hereunto set my hand and seal this thirty first - day of December - 1793
