The record of this officer shows that James C. Biddle was transferred from Company C to Co. G, 84th P.V. on July 26, 1863, and again transferred to Co. E, 84th P.V. and that he was transferred from Co. E to the non-commissioned state some time between 1864 and 1865. He was discharged from the latter Co. on 1865 with the 57th Regt. P.V. See also file in the Adjutant General's Office, War Department, Washington, D.C. His name is not on a detached non-commissioned list of the 84th P.V. as a Capt. Biddle having been promoted by the General Court.
