War Department, A. G. O., October 8, 1934- To The Adjutant General, Commonwealth of Pennsylvania, Harrisburg, Pennsylvania.

1. The records show that one William H. DeHaven was enrolled and mustered into service May 2, 1861, at Harrisburg, Pennsylvania, as a private in Co. F, 25th Regiment Pennsylvania Infantry (3 Mos., 1861), to serve three months, and was mustered out with the company and honorably discharged July 28, 1861, at Harrisburg, a private. His age is shown as 20 years.

2. The records also show that one William H. DeHaven was enrolled August 7, 1862, at Harrisburg; was mustered into service August 8, same place, as a private in Co. B, 127th Regiment Pennsylvania Infantry, to serve 9 months and was honorably discharged February 16, 1863, on surgeon's certificate of disability, a private. His age is shown as 21 years. Occupation, carpenter.

3. The records further show that one William H. DeHaven was enrolled July 15, 1864, at Harrisburg; was mustered into service July 15, 1864, as a private in Capt. Sanno's Co., Pennsylvania Cavalry (100 Days, 1864), and was mustered out with the company and honorably discharged October 29, 1864, at Harrisburg, a 6th sergeant. His age is shown as 22 years.

4. Nothing has been found of record to show that the above services were rendered by one and the same man, although the records of the first two given above were furnished to the Veterans' Administration in connection with the same claim number.

5. The name William T. DeHaven has not been found on the rolls on file of soldiers in service from the State of Pennsylvania in either the Regular or Volunteer Army during the period of the Civil War.
