1. An investigation of the records on file in this office show that Andrew L. Kuhn was enrolled in Perry County, Pennsylvania, October 16, 1862, for nine months; was mustered into the service at Harrisburg, Pennsylvania November 6, 1862, as a private, Company F, 177th Pennsylvania Drafted Militia Infantry, and was mustered out and honorably discharged August 4, 1863, as a private.
