Feb 7 19<sup>th</sup> Negro Thomas Wright declaring himself a freeman, is a married man, his wife in fact is lately from Chester, Towns Lancaster County where he has one child. Intends to reside in this city for some time, at the House of Jacob Laws of Calver - aged about thirty one year, about five feet eight inches high dark complexion thin build

Feb 20 Negro James Johnson aged about 40 years by usual view a laborer of a dark complexion, about five feet eight inches, thin build resides with Peter Handlars

March 2 Negro Hannahs blood aged about 22 years thin build her complexion not very dark resides with Francis Thurston in Lancaster, by one partner a married man, she being lately from Harrisburg declaring her self to be a free woman under her self

March 28 Negro Francis Nes aged about 27 years thin build about five feet six inches high of a dark complexion resides with Francis Thurston in this city, lately from upper Maryland in the western part of this State under by her self, declares her self a free woman

March 30 Mullato James Luxey aged about between 25 & 30 years about five feet high thin build, he is lately from Shepleys County Currituck County, in North Carolina in this city he being a single man now lives with Peter Handlars in a slave town in Adams city of our town

May 14<sup>th</sup> Paid Negro Peter Wellams of dark complexion, about five feet nine inches high, aged about 31 years of age single man declaring himself free, lately from Lebanon County by one partner a laborer, resides as a hiring with David C. Sherman in this city

June 3<sup>rd</sup> Paid Negro Sarah West aged about 22 years a short slender woman of a dark complexion, lately from the Madell (she), residing with her mother Ostons West in a slave town in this city

July 13<sup>th</sup> Paid Negro John Freeman, declaring his self a freeman, aged about 25 years lately from Pittsburg about five feet high 2 slender build by one partner a partner, resides at the corner of Market Street in this city, he is a laborer of Lancaster, by one partner a laborer

July 20 Mullato William Holland, he declaring himself a freeman, about six feet high slender build of a light yellow complexion - single man, now resides at Jacob Laws in Shepleys County, by trade a laborer from Harrisburg, having no family aged about 21 years

August 6<sup>th</sup> Paid Negro Peter Sping, who was one in captivity in this city a servant to the late George Sping, who had been in the hands of the late Peter Sping, with nails in orange shell, was seen to have been for some time with the late Sping

Sept 20<sup>th</sup> Paid Negro Joseph Jackson, about five feet five inches high deep black complexion, not very stout, aged between twenty two & thirty years, is a single man, resides in Adams town with Jacob Laws who resides in Adams town, he declaring that he was born in Chester, first came to the County of Lancaster nearly five years since by one partner a laborer

Sept 20<sup>th</sup> Paid Negro Andrew Smith aged about twenty eight about five feet ten inches high of a light complexion thin make, single man is a free man and under his name with the late Francis Triggs man Mullato single man has no family, has his home at the corner of Galloway in Adams town by one partner a laborer

Sept 20<sup>th</sup> Paid Negro boys Treble aged about about thirty years a single man, dark complexion, thin make, about five feet ten inches high, with his own hands with George Triggs in this city, lives at present with the widow George also a laborer, but intends to shift his lodging, and hopes to see as he can get a place, at the present time he has been out of the city for the twelve years, and only returned a few days of days before he came to the city

Sept 20<sup>th</sup> Mullato John Sherman aged about 29 years has no family, follows the occupation of blacking shoes and boots keeps his shop in the corner of the Benjamin Franklin in the corner of the corner of the city, lately from York County, has no family 5 feet 9 inches high declares her self to be a free man
