Peter Richer of the County of Green and State of  
Tennessee for Divers good Causes and Considerations  
the Whereunto Having Recourse had ordained constituted  
and appointed and by these presents do make ordain  
constitute and appoint Nathan Beach Esq of Sevier  
County in the State of Pennsylvania my true and lawful  
Attorney for me and in my Name to Draw the patent for  
my Land which belongs to me for my Services in Northamp-  
ton County Pennsylvania Commanded by Capt Philip  
Shawder and Discharged by order of his Excellency John  
Dickerson November 16 1784 at said Dickerson by  
Capt Philip Shawder for me and in my Name and for  
the use to give Demand Receive and Receive the patent  
of the aforesaid Donation Land giving and by these presents  
granting to my said Attorney my sole and full power and  
authority to take pursue and follow such Legal Course  
for the Recovery Recovering and obtaining the same as I may  
self mete or shall do where I personally present and  
upon the Receipt of the same Acquittance and other sufficient  
Discharges for me and in my Name to make sign Seal  
and Deliver as also one or more attorney or attorneys  
under him to substitute or appoint and at his pleasure to  
Revoke and further to do perform and execute for me and  
in my Name all and singular thing or things which here  
or may be hereafter touching the premises as fully  
thoroughly and in liberty as if the said Peter Richer in my own  
person might or could do or cause to be done in and about  
the execution of the premises by Virtue of these presents  
in witness whereof I have hereunto set my hand and  
Seal this fifteenth Day of September 1809
