And I the said Richard Collins do, for my self, my heirs, executors, administrators & assigns hereby, Covenant & agree to and with the said Henry Ridgway his heirs & assigns, that I the said Richard Collins, my heirs, executors, administrators & assigns shall and will at any time or times hereafter, at the request, cost & charges of the said Henry Ridgway, his heirs and assigns, make, seal execute or cause or procure to be made sealed, executed, all & every such reasonable act or acts, thing and things conveyance or conveyances, assurance or assurances in the Law whatsoever for the perfect granting, conveying, remising, releasing, transferring & assigning, all & singular the right, title interest, claim & demand, which I the said Richard Collins, have or which I the said Richard Collins my heirs executors, Administrators may at any time hereafter have of, in and to the Land, pay, monies, & other the premises hereby granted & assigned & of, in and to every part & parcel thereof, unto the said Henry Ridgway his heirs & assigns to the only proper use, and behoof of the said Henry Ridgway his heirs & assigns for ever, as by his or their counseil, learned in the Law, shall be reasonably advised, devised or required.

And I the said Richard Collins, do hereby appoint the said Henry Ridgway my true lawful Attorney irrevocably to ask, demand, solicit & obtain in my name or otherwise, but for the sole use & behoof of the said Henry Ridgway his heirs

and assigns for ever from the United States & from the commonwealth of Pennsylvania respectively a grant or grants, patent or patents for the Land aforesaid in his own name or names. And also to demand receive all such pay sum or sums of money for Annuages of clothing, rations, rewards, gratuities, prize monies, commutations or otherwise however due to me as aforesaid, and upon receipt thereof to pay any requisite receipt or acknowledgment for the same, hereby ratifying all and confirming what ever my said Attorney may do respecting the same. And I the said Richard Collins for my self, my heirs, executors & Administrators, do Covenant, promise & grant to and with the said Henry Ridgway, his heirs, executors, Administrators & assigns, that I will not revoke or annul the power of attorney herein contained, or do any act which shall impede the said Henry Ridgway in soliciting or obtaining a grant or grants, patent or patents for the land aforesaid receiving the pay, monies or other the premises aforesaid, In Witness whereof I have hereunto set my hand and seal this 18th day of August 1792,
