KNOW YE that I, Conrad Klein late a private on the
First Pennsylvania Regiment -

in the Service of the United States of America, for and in Consideration of the Sum of
Fifty pounds to me in Hand paid, at anefore the Ensealing
and Delivery of these Presents, by Gideon Markee in the County of
Dover State of Pennsylvania.

The Receipt whereof I do hereby acknowledge, HAVE granted, gained, sold, remis-
ed, released, quit claimed, transferred, and assigned, and by these呈ents DO grant, bar-
gain, sell, remise, release, quit-claim, transfer, and assign to the said Gideon Markee

and his Heirs and Assigns for ever, all thight, Title, Interest,
Property, Claim, and Demand which I now have, and all the Right, Title, Interest, Claim,
and Demand, which I, my Heirs, Executors, or Administrators, any Time hereafter
may have, to all the Land which I am entitled to; and to all the Lands which I, or either
of them, may at any Time hereafter be entitled to from the Congress of the United States
of America; AND ALSO, all the Lands which I am entitled to from the Common-
wealth of Pennsylvania - by Virtue of an Act or Acts of the Legislature of
the said Commonwealth, for my Services as a private soldier
as aforesaid in the Army of the United States of America, for, and during the
War with Great Britain, and to every Part and Parcel thereof: - AND ALL such Pay,
Sum, or Sums of Money, for Arrearages of Cloathing, Rations, Rewards, Gratuities,
Prize-Monies, Commutations, or otherwise howsoever due to me for my Services, as a-
foresaid. To HAVE, HOLD, RECEIVE, TAKE, AND ENJOY the said Lands, Monies, and
other the Premises hereby granted and assigned unto, and to, and for the only proper
Use and Behoof of the said Gideon Markee his Heirs, Executors, Ad-
ministrators, and Assigns, for ever: AND I the said Conrad Klein
DO, for myself, my Heirs, Executors, Administrators, and Assigns, hereby covenant and
agree to and with the said Gideon Markee his Heirs and Assigns,

that I, the said Conrad Klein my Heirs, Executors, Administrators,
or Assigns, shall and will at any Time or Times hereafter, at the Request, Cost, and
Charges of the said Gideon Markee his Heirs or Assigns, make,
seal, and execute, or cause or procure to be made, sealed, and executed, all and every
such reasonable Act and Acts, Thing and Things, Conveyance and Conveyances, Affur-
mance and Assurances in the Law whatsoever, for the perfect granting, conveying, remis-
ing, releasing, transferring, and assigning, all and singular the Right, Title, Interest,

Demand, which I, the said Conrad Klein have.

Heirs, Executors, and
Monies, and other the Premises hereby granted and assigned, and of, and to every Part and
Parcel thereof, unto the said Gideon Markee his Heirs and

Assigns, to the only proper Use and Behoof of the said Gideon Markee
his Heirs and Assigns for ever, as by his or their Counsel, learned in the Law, shall be
reasonably advised, devised, or required: AND I, the said Conrad Klein,

do hereby appoint the said Gideon Markee my true and lawful
Attorney irrevocably, to ask, demand, solicit, and obtain in my Name, or otherwise, but
for the sole Use and Behoof of the said Gideon Markee his Heirs and
Assigns for ever, from the United States, and from the Commonwealth of Pennsylvania
respectively, a Grant or Grants, Patent or Patents, for the Lands aforesaid, in his own
Name or Names; AND ALSO, to demand and receive all such Pay, Sum or Sums of Mo-
ney, for Arrearages of Cloathing, Rations, Rewards, Gratuities, Prize-Monies, Com-
mutations, or otherwise howsoever, due to me as aforesaid, and upon Receipt thereof, to
pass any requisite Receipt or Acknowledgement for the same, hereby ratifying and con-
firming all and whatsoever my said Attorney may do respecting the same: AND I, the
said Conrad Klein for myself, my Executors,

and Administrators, DO covenant, promise, and grant to and with the said Gideon Markee
his Heirs, Executors, Administrators, and
Assigns, that I will not revoke or annul the Power of Attorney herein contained, or do
any Act which shall impede the said Gideon Markee
in soliciting or obtaining a Grant or Grants, Patent or Patents, for the Land aforesaid,
and receiving the Pay, Monies, or other the Premises aforesaid. IN WITNESS
whereof, I have hereunto set my HAND and SEAL, this Fourteenth Day of
