 ordain and constitute and in my place and stead put and depute Jacob
 Degen of Heidelberg Township aforesaid my true and lawful Attorney
 irrevocable for me and in my name and stead but to the sole use of him
 the said Jacob Degen his Heirs and Assigns forever to sue demand
 and by all lawful ways and means recover and receive all such
 sum or sums of Money as well as grants or confirmations Lands and
 Tenements or other Demands whatsoever by the United States or the State
 of Pennsylvania or any person or persons acting under their authority and
 I also give and Grant unto my said Attorney full Power and absolute
 Authority to sell and dispose of all and singular the Lands and Ten-
 ements Grants and Donations which I as Administrator of the
 said John M. Winley may be entitled to or of right may claim in
 Virtue of any Act of the United States in Congress assembled or under the
 Authority of any Act of Pennsylvania for or by reason of his having
 served in the said American Army and by good and sufficient
 Assurance in the said Grant convey and confirm to the purchasers
 or Purchasers the Fee Simple and Inheritance thereof hereby Granting
 unto my said Attorney full Power and Authority to appoint one or
 more Attorneys under him or them for the purpose of the said
 Ratifying and confirming all & singular whatsoever my said
 Attorney or his substitutes shall or may do in the Premises by Virtue
 hereof In Witness whereof I have hereunto set my Hand and seal
 the Seventeenth Day of December in the Year of our Lord One
 Thousand seven hundred and thirty one
