The Litigation files are grouped alphabetically by case name; the Death Sentences are grouped by name of defendant; the Merit Selection of Judges are grouped according to District Justices, Supreme Court of Pennsylvania, Superior Court of Pennsylvania, Commonwealth Court of Pennsylvania, and Common Pleas Court; the Miscellaneous Research are grouped by subject; and the Gleason Papers groupings are Hearing Transcripts and Appendices to the Report of the Select Committee to Investigate State Contract Practices and random investigation subject files.

Files contain correspondence, reports, hearing transcripts, court papers,clippings, and related material of the Counsel to the Governor.
