

Survey the 26<sup>th</sup> Day of October 1785 In Consequence of a Warrant of Preemption

for 1000<sup>acres</sup> of which the following is a true Copy LAND Warrant No. 108 Land Office Treasury Warrant No. 108. To the principal Surveyor of any County within the Commonwealth of Virginia. -- This shall be your Warrant to Survey and lay off in one or more Surveys, for Thomas Gist in Right of his father Christopher Gist, his Heirs or Assigns, the Quantity of one thousand Acres of Land, due unto them <sup>as day</sup> on Preemption as per Certificate from the Commissioners for the District Monongahela Yohogania & Ohio & in Consideration of the sum of four hundred pounds current Money paid into the publick Treasury, the Payment whereof to the Treasurer hath been duly certified by the Auditors of publick Accounts, and their Certificate received into the Land Office. Given under my Hand and the Seal of the said Office on this eighth Day of March in the Year One Thousand Seven Hundred and eighty. [Certified on the Back of the above.]

This Warrant was Produced to me the 8<sup>th</sup> day of July 1780 when Capt. Thomas Gist made Entry on my Books for four hundred Acres of Land Part of the one thousand Miles West of Ohio land at present held by Sam'l Lyon Jr & Sam'l Lyon Jr bounded by the Line of the S<sup>t</sup> Gist, the Lawhill hill, Isaac Pearce, Jas' Finley & John Corhill. a. Vacant Land by the S<sup>t</sup> Lyons failing to Enter the same with the Commissioners and Comply with the rules & regulations of the Office & Law in that Case made & Provided.
