

Draught of a tract of land situate in Greenwood Township Milliflin County containing eighty nine acres and 96 perches and the allowance of six p<sup>er</sup> cent for roads &c. Survey began the 5<sup>th</sup> of March & finished the 24<sup>th</sup> of March 1803 - in pursuance of a Warrant granted to David Drennon dated the 24<sup>th</sup> day of August 1802 -

Notes & References: The part colored yellow shown on the above draught contains twelve acres and 65 perches & allow<sup>er</sup> &c and was included in a survey made for Charles H<sup>er</sup> Gea the 15<sup>th</sup> of Nov<sup>er</sup> 1791 - said to contain 232 acres and 37 perches in pursuance a Warrant in the name of George Hays dated March 10<sup>th</sup> 1786 -

Charles H<sup>er</sup> Gea appears on the ground at the time D. Drennon's warrant was executed and objects to the survey being made by reason that the above part of G. Hays' survey was taken in -

The part colored green on the above draught shows a survey of sixteen acres & 26 perches &c made for Heathias Dwards the 22<sup>nd</sup> of Nov<sup>er</sup> 1793 in pursuance of his Warrant dated the 9<sup>th</sup> day of May 1793 - he also appears at the time D. Drennon's survey was made is much dissatisfied and objects to a Return being made.


At a House in which Robert Patterson resided at the time the survey was made for D. Drennon he claims all the land surveyed for Drennon yet appears dissatisfied that the survey be made under the expectation that an accommodation may take place between himself & Joseph Semple who appears the owner of the Warrant in the name of David Drennon -
