



A Draught of Four Tracts of Land, Situate in Upper Milford Township, in the County of Northampton, in the State of Pennsylvania. Belonging the greatest Part thereof to Daniel Schwartz. But none of those Tracts being as yet Patented. So it is agreed Between the Partiers thereof that the said Four Tracts be all granted by one or more Patents to the above named Daniel Schwartz. The first Tract Number 1 Contains Two hundred acres of Land and the usual allowance for Roads and was originally surveyed to George Shoemaker by Warrant of the 23 November Anno 1736, who by his Will dated 4th June 1756 devised the half part thereof to his son Frederick Shoemaker and the other half Part to his son Adam Shoemaker, and then the said Land was sold several Times until Lately the greatest Part thereof was sold to the abovenamed Daniel Schwartz as by the Deed Polls for the same will appear. The second Tract Number 2 Contains Fifty acres and 99 Perches and the usual allowance Being the equal half part of a Tract of 100^{acres} & allowance which also formerly was surveyed to the said George Shoemaker by Warrant of the 28th October Anno 1737 the same was afterwards divided to his Two Sons whereof the above Part did belong to Adam Shoemaker and consequently sold several Times as above said. ^{No. This whole Tract of 100^{acres} The Tract Number 3 Contains Nineteen acres and 49 Perches & allowance being Part of a Tract of 27^{acres} 191 per. etc. to be Patented formerly Surveyed to George Hoffman and returned in the Surveyors Office Jan 6th 1753 the Remainder was sold to Lewis Klotz (alias) above was sold Several Times like as the other above recited Land. The Tract Number 4 Contains Twelve acres and 99 Perches of Land and the allowance being Part of a Tract of 87^{acres} & allowance which was formerly Surveyed to Jacob Gertenheir by Warrant of the 23rd October Anno 1741 which said Tract was also sold many Times until at Last the above part thereof was sold by Michael Schneider to the above named Daniel Schwartz it being the fourth described Tract in his Deed Poll of Anno 1785. The said Four Tracts Contain together Two hundred and Eighty Two acres and Seventy Seven Perches of Land together with the usual allowance at Six per Cent for Roads. Part of the said Lands was formerly resurveyed and divided for the then Possessors thereof And now drawn for the said Daniel Schwartz on the 5th March Anno 1788. Pr David Shurtze —}
