

Draught of a tract of land situate in Fannet township Franklin County containing containing in all 193 acres 17 perches & allowance of six per cent for floods &c. Surveyed 20 October 1829. In pursuance of a contract with the Board of Property for carrying into effect the several Acts of Assembly relating to unpatented lands under Proprietary rights &c. And by virtue of an order of survey dated 16 December 1767 No. 4652 granted to Arthur Mc Michle for 200 acres "on the West Side of the Kittatinny Mountain joining John Ward and Samuel Culbertson in Fannet Township" Wm. S. Davis William Hamilton, Contractors.

To Jacob Spangler Esq. Surveyor General. Report. The above described tract is covered by the following Office Rights viz: that part marked A was formerly survey'd in dispute between Arthur Mc Michle & John Ward. there Office rights not stated as per draught. The part B covered by a Warrant to John Taylor dated 23 October 1801 and claimed under said title not pat'd. The part C covered by a Warrant to John Ward for 100^a dated 22d January 1793 and claimed under said title not Pat'd. The part D included with in the lines of a larger tract of 109 1/2 As held under a warrant to Benjamin Van Scoyck dated 26 March 1794. The whole of the above land is fairly located by the above order. For the part A no other right has been found but that of Mc Michle above stated not pat'd. The part A owned & occupied by John Taylor & Geo. Johnston. The part marked B owned by Jno. Harvey & George Johnston & occupied by do. John Statte owner & occupier of the part C. And George Stewart owner of the part D & occupier of do. John McVelty tenant under Johnston.
