

The late Proprietary William Penn Esq^r by Deed of the 12th of October 1681. Granted to Joshua Hastings one thousand acres of land to be laid out in this Province.

And the same day granted to John Marsh one thousand acres to be laid out in the sd Province.
By warrant from the sd Proprietary 1280^{acres} part of the said purchase was laid out to the sd Joshua & John in the year 1685 in one tract in Chester County.

In the year 1716 there being no division made between sd Joshua & John sd Joshua Hastings procured 189 acres part of the sd 1280 acres to be resurveyed and obtained a Patent himself for the same, and afterwards dyed intestate; since whose decease all his children granted the sd 189 acres to one James Sorrill who conveyed the same unto Benjamin Hickman, & he to Gainer Pierce.

In the year 1685 there was surveyed & granted to Mary Fincher the Relict of Francis Fincher deceased 965 acres of land in one tract in Chester County adjoining to the sd 1280 acres part of which tract of 965 acres some Welsh Purchasers pretended to have a prior right unto and therefore John Fincher son and heir of the sd Francis & Mary (who were then deceased) relinquished such part of the sd land as the Welsh claimed and in the year 1702 procured a warrant from the Proprietary's Commissioners directed to one David Powell requiring him to resurvey to the sd John Fincher the Remainder of the sd tract of 965 acres not taken by the Welsh Purchasers, in making of which resurvey the sd David Powell run into the sd land surveyed for Hastings and Marsh 17 years before and cut off a considerable piece of the same which he returned together with the remainder of Finchers Tract (free from Welsh claims) into the land office for 330 acres and thereupon a Patent was granted to sd John Fincher for the same as part of the 965 acres granted to his Mother; and the sd John sold the sd 330 acres to Mr. Thomas Paschall who granted it to his son Thomas (since deceased) whose widow ye now wife of George Ashbridge hold the same. In the year 1714 Joseph Jarvis having purchased 650^{acres} of sd Marshes 1000^{acres} (upon his agreeing to relinquish all lands before laid out in sd Marshes right) obtained a warrant from the Proprietary's Commissioners for laying out the same to him and thereupon Isaac Taylor then Surveyor of Chester County surveyed unto the sd Joseph Jarvis 190^{acres} of the sd 1280 acres. But upon his making return thereof the same was objected against by Secretary Logart & ordered to be laid aside, and afterwards part of the land therein contained was confirmed to Joshua Hastings by the Patent aforesaid. In the year 1715 sd Joseph Jarvis had 460 acres of land laid out to him in sd right on a Branch of Pequea Creek and soon afterwards there was surveyed to one Thomas Eldridge (in right of Thomas Andrews) 250 acres of land adjoining to sd 460^{acres} which lying remote from neighbour's the sd Eldridge wholly relinquished it, & took up the like quantity elsewhere. Whereupon sd Joseph Jarvis acquired Isaac Taylor that he would lay his right of 190^{acres} on part of sd 250^{acres} and purchase the residue of the Proprietary land accordingly. Built & improved upon the same which he holds to this day. I have taken some remarks of this Taylor's writing to ye Hon^{ble} Proprietor and find concerning ye 190 acres of land in Goshen yt John hath made so many writings of yt land viz. deeds, leases & other writings yt his understanding must needs be much enlarged since yt time above the truth to know now thanks then knew John Taylor well knows I never released ye sd land John Taylor would neither say or write as he does before me. Which I am able to make good any time.
