

Pursuant to a warrant under the hand of the ^{Prop^r & Gov^r.} ~~Surveyor of Property~~ and the seal of the Province dated the 22^d day of the sixth month 1701.

There is resurveyd unto Walter ffaucit and Edward Pritchel a tract of land in the township of Ridley in the County of Chester and the same subdivided between the Walter & Edward into ten Lotts or parts to each party five, three of fast land and two of Marsh.

Walter ffaucit his first Lott of marsh beginning at a maple tree in line of the Widow Neals's land from thence extending by the said land south forty seven degrees eastward eighty five perches to a post by Delaware river thence by the said river north fifty eight degrees easterly thirty five perches to a post Thence by Edward Pritchets marsh north thirty five degrees westerly ninety five perches to a post Thence south sixty two degrees westerly fifty perches to the first mentioned maple tree Containing twenty one acres and a quarter.

His second lott of marsh beginneth at a white oak by the side of Edward Pritchets field from thence south twenty five degrees thirty minutes easterly by Edward Pritchets land seventy one perches to a willow tree by Crurn Creek thence up the said creek ~~sixty~~ twenty four perches to a post from thence north twenty five degrees westerly seventy four perches to a black oak, Thence by Edward Pritchets land south sixty two degrees westerly twenty four perches to the place of Beginning Containing ten acres and three quarters.

His first lott of fast land beginneth at a hickory tree in the line of the Widow Neals's land from thence south forty seven degrees east twenty six perches to a post in the said line from thence by Edward Pritchets land north sixty three degrees easterly fifty six perches to a post thence north fifty degrees east forty one perches to a black oak by Crurn Creek Thence up the said creek on several Courses sixty two perches to a Dogwood tree from thence by the said Pritchets land south forty three degrees westerly seventy perches to a small black oak. Then by the said Pritchards land south sixty two degrees westerly fifty perches to the place of beginning Containing nineteen acres.

His second lott of fast land beginneth at a spanish oak at the corner of Edward Pritchets land from thence north forty seven degrees westerly in the Widow Neals's line thirty six perches to a black oak from thence north fifty eight degrees easterly sixty six perches to a dog wood tree by Crurn Creek from thence down the same fifty four perches to an ash tree from thence south fifty eight degrees west by Pritchets land ninety eight perches to the place of beginning. Containing seventeen acres and three quarters.
